## Slip and Fall Recoveries

**The Law Offices of Justin G. Morgan, P.A.** recently made recoveries totaling \$160,000.00 for a client who had two (2) slip and fall accidents in two different retail stores, within a one year period.

The first accident caused our client back and knee injuries. The second accident exacerbated our client's injuries. Our client ultimately needed a knee surgery and a back surgery. As is typical in slip and fall matters, both retail stores completely and totally denied that they caused our client to fall. Both stores argued that our client's injuries were pre-existing and that the "other accident" caused our client's injuries.

After substantial finger pointing, litigation, including an arbitration, the cases were settled prior to trial, with a total recovery of \$160,000.00, which allowed our client to pay off all of her medical bills, and she



received a substantial amount of money for future medical care and for pain and suffering damages.

## HOW TO PROCEED WITH SLIP AND FALL ACCIDENTS

It is sometimes very difficult to prove who is at fault for slip and fall accidents. Unless it is a rare case involving the intentional conduct of a defendant, a slip and fall case will require the plaintiff to prove negligence. 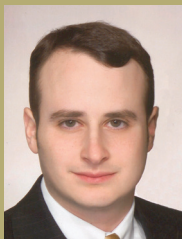
