## \$100,000.00 AUTO ACCIDENT RECOVERIES

The Law Offices of Justin G. Morgan, P.A. recently made recoveries of \$100,000.00 for a client who was injured in two automobile accidents within a small period of time. Both insurers attempted to not pay our injured client any monies, even though they each had a \$50,000.00 maximum policy limit for bodily injury.

After much aggressive negotiation, **The Law Offices of Justin G. Morgan, P.A.** reached a settlement with both insurers. They each agreed to pay the \$50,000.00 policy limit on each accident claim resulting in a \$100,000.00 recovery for our client. This was the maximum insurance available for our client's injury claims.

Slip and fall accidents can result from a dangerous condition that someone failed to take care of, like a wet floor that wasn't clearly marked, or a loose rug that should have been nailed down.

Examples of common slip and fall hazards include:

- **No warnings posted on known hazards or construction areas**
- **Wet floors**
- **Loose steps or hand rails**
- **Icy or slippery stairs or walkways**
- **Debris from a spill**
- **Inadequate lighting**
- **Uneven floors or sidewalks**
- **Known construction defects**

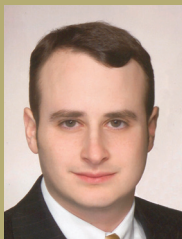
