The number one misconception that people have is that slip and fall cases are easy to win. Attorney Justin G. Morgan speaks with people who tell him that simply because they fell on someone else's property, that automatically means that they should win their case. Our office wishes that were true! It would make life easier. The truth is that slip and fall cases are actually very difficult to prove at trial.

Court statistics say that only one in five slip and fall cases result in a money verdict for the injured person. That is only a 20% chance of winning your case in front of a jury. On the other hand, **The Law Offices of Justin G. Morgan, P.A.**, has had substantial success in our practice with many slip and fall cases, settling many claims before the case reaches trial, due to successful prosecution. However, clients need to understand how much time, money and work has to go into these cases in order to make them successful.

To prove a slip and fall case, we have to prove:

- Where you fell and that you actually fell
- What caused you to fall
- How long the problem existed
- That the thing that caused you to fall was unreasonably dangerous
- That you were not the cause of your fall



Now perhaps you understand how complicated this can be. You have to have your ducks in a row about the facts of your fall, because insurance companies defend these cases by saying that the person who fell wasn't paying enough attention to where they were walking. The sad part is that juries tend to believe that argument and that is why these cases are so hard to prove.

An experienced lawyer who knows how to prove these cases **BEFORE** going to court or trial can not only encourage the insurance company to come to the settlement table but also put all the evidence together in such a way that puts some fear into the insurance company. It is important to remember that how your case is handled and whether it is put together the right way can make all the difference.

7. Call The Law Offices of Justin G. Morgan, P.A. and let us handle all the insurance and legal claims.

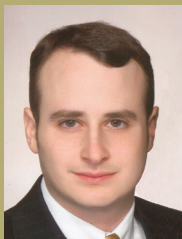
