\$275,000.00 SETTLEMENT CAR ACCIDENT VICTIM

JURY TRIAL VICTORY

THE LAW OFFICES OF JUSTIN G. MORGAN, P.A. represented a doctor's office for payment of medical bills denied by an automobile insurance company as not being reasonable or related to the automobile accident.

While not all cases result in a lawsuit being filed, the automobile insurance company adamantly refused to pay in this case. Many times insurance companies will deny coverage for as long as possible, hoping that the injured parties will not pursue their claim. In order to proceed and receive the protection that the doctor's office was entitled to, **THE LAW OFFICES OF JUSTIN G. MORGAN, P.A.** filed a lawsuit and brought the case to trial.

After a three day jury trial, the jury came back in less than 45 minutes, and awarded 100 percent of the sought insurance benefits to the doctor's office. The insurance company was also ordered to pay to the doctor's office all the reasonable attorney fees and costs incurred. The insurance company settled this portion and paid fees and costs of approximately \$88,000.00.

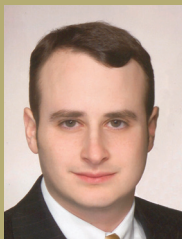
