Slip and Fall Recovery

The Law Offices of Justin G. Morgan, P.A. recently made a recovery of \$100,000.00 for a client who slipped and fell while shopping in a store. Our client had many injuries from the accident.

Upon presentation of the claim to the store, the initial offer made was \$5,000.00 and they blamed our client for causing the fall. A low offer and blaming the victim for their injuries is very typical for insurance companies as they do not want to pay for claims against their insured. It takes expertise and perseverance of an experienced law firm to force reluctant insurance companies to adequately compensate injured victims.

The Law Offices of Justin G. Morgan, P.A. immediately requested, from the store, their video of the fall. The store refused to provide us with the video. Our client was confident that the floor was wet and there was nothing he could have done to have avoided the fall.

A lawsuit was filed on behalf of the client and the store vigorously defended and continued to refuse to provide the accident video.



During the course of the litigation, Attorney Justin G. Morgan secured a Court Order which required the store to turn over the accident video.

Once the video was received and reviewed, the evidence was very clear that the accident was the fault of the store, and the fall was severe. As a result of our aggressive efforts to obtain the video evidence the store was hiding, we were able to settle our client's case for \$100,000.00 prior to trial.

EVIDENCE TO PROVE YOUR **SLIP AND FALL INJURY CLAIM**

It is sometimes very difficult to prove who is at fault for slip and fall accidents. Store and property owners and insurance companies typically refuse to take responsibility and often, blame the accident on the injured victim. Property owners may be reluctant admit responsibility and to provide documentation that may show their liability. They generally do this so they will not be forced to provide you compensation for the injuries from the accident.

Generally, a plaintiff in a slip and fall case is required to prove fault. This can be very difficult when the property owner is reluctant to cooperate. Store and property videos are a wonderful tool to provide proof of liability but if not provided voluntarily to plaintiffs can present a very frustrating barrier. After a slip and fall accident clients should be focusing on their recovery, not handling the legal aspects of their case or negotiating with insurance companies. It is fortunate that **The Law Offices of Justin G. Morgan, P.A.** has the experience necessary to make the process of obtaining compensation in slip and fall matters, significantly easier for victims.

In order to successfully recover compensation after a slip and fall accident, Attorney Justin G. Morgan will gather the evidence to support your case. If necessary, he will compel the defendant to produce the evidence through a legal process known as "discovery." If judicial intervention is necessary, he will pursue it to the fullest extent of the law.

Attorney Justin G. Morgan will negotiate with the insurance company on your behalf. However, in some cases it may be necessary to file a lawsuit and proceed with a trial in order to recover compensation for slip and fall victims. It is important for victims to understand the complexity of proving fault and ultimately receiving adequate compensation for their injuries. Compensation may include medical expenses, lost income, pain and suffering, and loss of quality of life.

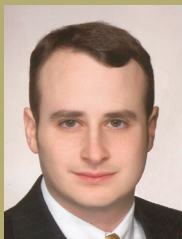
