## \$200,000.00 AUTO ACCIDENT RECOVERY

The Law Offices of Justin G. Morgan, P.A. recently made a recovery of \$200,000.00 for a client who was in a work van roll-over accident. Our client had a very serious head injury and facial burn as a direct result of the accident.

When The Law Offices of Justin G. Morgan, P.A. was retained, our client, who was not a U.S. Citizen and who did not speak any English, could provide us with virtually no information about the accident. We discovered that he was sleeping at the time of the accident and was unfamiliar with the area.

The Law Offices of Justin G. Morgan, P.A. immediately and comprehensively investigated this accident. Our investigation revealed that the work van was not equipped with seat belts and there was no workers' compensation insurance coverage available for the benefit of our client. However, within forty-five days of the retention of our office and after demand to the liability insurance company, the insurance company for the van agreed to pay its insurance policy limit. Our client recovered \$200,000.00.

One of the leading causes of death and injury on our roads is due to vehicle rollovers. No one foresees driving along



and having their vehicle rollover. We all assume that our vehicles are made and protected in such a fashion that all four wheels will stay on the road. However, if your vehicle does in fact rollover, not only is your body and vehicle turned upside down, but your life may be turned on its head. ## SLIP AND FALL IN FLORIDA

Injured on another person's property? Negligent property owners should never escape liability for a slip and fall accident.

There are no hard and fast rules for proving fault in slip and fall injuries, as each case is unique and based on whether or not the premises owner allowed a dangerous situation to persist. This is not always easy to prove and generally requires the intervention of an experienced lawyer, familiar with how courts determine fault.

If you are injured because a property owner or a business establishment has failed to provide a safe environment, you may have the right to bring a claim for damages incurred due to your injury. These damages may include pain and suffering, medical expenses and lost wages.

The most important thing to remember after a slip and fall injury is preservation of evidence to show what caused your fall. **Take photos of what caused you fall!** Never discuss the specifics of the incident with an insurance company, as statements you provide may be used against you.

Be sure to see a physician about your injuries. Don't assume you just have sore muscles that will go away in a few days. The goal of any insurance company is not to pay, so the better you document what actually happened, the more **The Law Offices of Justin G. Morgan, P.A.** will be able to assist you in your personal injury claim due to a slip and fall accident.

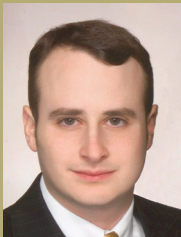
